#### **From the Minister:**

We had very successful services over Easter and I was pleased to once again be able to take part in the Inter-Church Walk of Witness through Downpatrick on Good Friday with Jack who played the trumpet that morning for a service in Strangford Lodge. It is something that all the churches in the town do together, a small act of witness, a reminder of the season, on what always proves to be a busy day for shopping and traffic.

This Calendar contains the details for our Spring Communion services which we hope all members will make every effort to attend. Later in the year I will be holding Communion Classes for anyone who would like to come. We also look forward to our Children's Day services, the date for this has been chosen at Ballee. Clough and Downpatrick still have to be arranged

Another important event will come at Clough when we will welcome John Larkin, QC, the Attorney General, who will be coming to give a talk on the legal case that surrounded the Clough meeting house in 1836. Mr Larkin has long had an interest in aspects of our denominational history and at this meeting he will be giving an account of this important legal decision that tied in to theological change. The result of the decision in 1836 was that the Non-Subscribers had to give up the original meeting house in Clough and we had to build our own new Church, which today is such a wonderful home for our worship. This happened at Clough and also at Killinchy and had special legislation not been brought in, in 1844 (The Dissenters Chapels Act) could have happened with virtually all our meeting houses. One of the legal experts involved in the struggles of 1836 was Joseph Nelson, a brother of the Downpatrick minister at the time (Rev S.C. Nelson) whose memorial can be seen in Downpatrick on the wall next to the pulpit.

It promises to be a very interesting evening and we expect a good attendance of people from all over. After the service we will be serving tea in the hall. Leaflets about the lecture are available in the church and more details can be found online at

### **Funeral**

Bobby Moffett died suddenly on Friday, 10<sup>th</sup> March. He was a life-long member of the Downpatrick congregation who had served it with great loyalty and devotion throughout his days. At the time of his death Bobby was the senior elder, having been an elder since 1975, and having also been a member of the church committee for 54 years. Bobby had been the representative elder for the congregation for 15 years and faithfully represented the congregation at meetings of the Synod and the Presbytery of Antrim wherever they were held. In the church, on the committee, in the various meetings he attended he was highly regarded for his wisdom and good sense. He regularly visited members of the congregation who were unwell or housebound and indeed was well known and respected throughout the district for his friendship, good neighbourliness and willingness to give support to those who were bereaved or in need in some way. Beyond the church Bobby faithfully served the Hollymount Rural Community Association, was a member of the Hollymount Lodge and was Chairman of the Field Committee of the Listoder Ploughing Society, travelling all over the world to follow the ploughing matches. He was also Vice President of the Hollymount Pipe Band, something which he greatly enjoyed, and it was fitting that Sammy Gill was there to pipe Bobby into the Church at his funeral, with Richard playing the organ. Well known and highly regarded throughout the farming community Bobby had worked as a drover in the sale yard almost from the time it opened. Following his death, when he was not there to set everything up for the first time, they held a one minute's silence for him in the yard. In a similar way at the first meeting of the Presbytery of Antrim convened after Bobby's death, they opened their meeting with one minute's silence for him. Both are testimony to just how widely Bobby was held in such high esteem. At the centre of Bobby's life was his family and Bobby was married to Eileen for almost 52 years until her sad death in 2009. The Downpatrick Church was filled to overflowing for his funeral service on Tuesday, 14<sup>th</sup> March which was conducted by Rev Dr David Steers, followed by burial in the church yard. During the service his granddaughter, Anna, representing all his grandchildren, read the poem entitled simply 'Bobby' written about him by his friend and neighbour Mickey Mageean. Our deepest sympathy goes to all of Bobby's family, to his children, Alistair, Hazel, Marion, Ann and Joan, and to their families, and to Bobby's grandchildren, Stephen, Neil, David, and Adam, James, William, Anna, and Amy, and David, Jenny, Samuel, Jonathan and Andrew, and the whole family circle.

### *The case of the Clough meeting house (1836): law reporting and pamphleteering*

#### Abstract

The case of *Dill v Watson* (1836) determined which of two parties in Irish Presbyterianism was entitled to the ownership of the Meeting House in Clough, County Down. It was the first Irish battle in a campaign in which litigation was the adjunct of theological controversy, and in the Clough case there is almost a fusion of legal and theological debate. What is striking (and fascinating) about the Clough case is that both parties published reports of the decision. Law reporting was for the parties to the Clough litigation no abstract record of a judicial decision but a further way for historical, legal, political and theological debate to be carried on. The two reports of the Clough case opened a distinct front in a pamphlet campaign that lasted until the Dissenters Chapels Act 1844 – if not beyond. This lecture explores this litigation and its background through the prism of the two partisan reports of the Clough case and the later law report by Thomas Jones. It examines the significance of the Clough case as a turning point in wider legal and theological controversy.
